AFFIDAVIT FOR ARREST WARRANT OR CAPIAS

BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being sworn by me, on oath stated:

My name is Erin Blust, and I am a peace officer of the City of DeSoto, Dallas County, Texas.

I have good reason to believe and do believe that on or about the 14TH day of April, 2017, one MILTON DAVIS, III, did then and there in the City of DeSoto, Dallas County, Texas, commit the offense of CAPITAL MURDER a violation of Section 19.03 of the Texas Penal Code, a CAPITAL OFFENSE. My belief is based upon the following facts and information furnished to me, the Affiant, on 4-21-17, by:

(x) T. Archibald #237 E. Blust #198 Peace Officer, DeSoto Police Department

On 04-15-2017 at approximately 0443 hours, DeSoto Police Officers responded to 409 Summertree Ln, Desoto, Dallas County, TX in regard to a medical emergency with Police. The caller advised that his father was slumped over in his vehicle and it appeared that he had been shot. Upon arrival, Officers observed a pickup truck and trailer parked in front of the residence parallel with the curb facing south bound. Reporting Officer observed that the driver's side and passenger side door was open on the vehicle. Reporting Officer observed an unconscious male in the driver's seat. The victim was later identified as T Grady. Desoto Paramedics M261 checked victim Grady and pronounced him deceased. Upon further investigation it was found that the victim's wallet was missing. Officers checked the area and located surveillance cameras from a neighbor that show the subject, believed to be the defendant, who was wearing a ball cap, long sleeve shirt jacket, pants, a backpack and carrying a gun in his right hand. In the surveillance video, Detectives observed that the defendant walked from the back of the victim's residence to the front and approached the victim while he was in his vehicle and shot him multiple times. DeSoto Detectives distributed still images of the defendant taken from the surveillance video. These still images are of the defendant just prior to the shooting of the victim. Later, Det. Blust received a call from a tipster who said that she knew the person in the images from the surveillance video and positively identified him Milton Davis, III b/m 11-07-1987. Detectives received the cell phone number for the defendant and a search warrant was completed for cellular records. The search on the cell phone data records of the defendant concluded that the defendant's phone was in the area of the offense at the time of the offense, but leaves this area after the offense has occurred.

I believe this information furnished by a fellow police officer a civilian witness suspect's corroborated statement is credible.
